Helping Families in Crisis ~

Services through this fund provide disaster relief, emergency communications for military personnel and families; counseling and safe shelter to those affected by domestic violence, rape, sexual assault and economic hardship; emergency assistance such as food, clothing and utility assistance to families and people in need.

Specific Non-Profit Organization:

To help offset the cost of fundraising, a 5% administrative fee is assessed on designated gifts to specific organizations.
